

2 - Medical Liability Exemption Term

Medical Team - Brazil 135

- 1- I declare that I am in good physical shape, and appropriately trained for this Test; 2- I certify that I am able to participate in this Event, I am of legal age, responsible for my actions;
- 3- I declare that I compete in this Event of my own free will and that I exempt the Organizers and the entire Medical Team, and others involved in holding the Event, from any responsibilities;
- 4- I hereby authorize medical care from the Official Race Medical Team;
- 5- I also understand that all material and equipment necessary for my development in this test are my responsibility;
- 6- I undertake to carefully follow the instructions of the organizers and the medical team, thus increasing my safety throughout the Event;
- 7- I am aware that there is a risk of serious accidents during this competition. I declare to assume of my own free will all the risks involved and their consequences - which include the possibility of trauma, disability, disappearance and even death. The risks of accidents in the activities involved in this competition are significant and involve the possibility of displacement, being run over, dislocations, trauma, fractures, burns, bites, animal and insect stings, contact with poisonous plants, accidents, risk of possible permanent paralysis and death . Although specific rules, Medical Team, equipment and discipline can reduce inherent dangers, the risk of serious harm exists;
- 8- I also declare to be aware of the following rules:
 - a- *To participate in the Test, I am in possession of a medical declaration (medical certificate) releasing the athlete for the competition (competitive level sport). The organization may request, at any time, the presentation of this Medical Certificate, under penalty of disqualification if the document is not presented. In the event of an accident occurring as a result of any pre-existing medical factor, which could have been detected through this Medical Certificate, the official BR 135 Ultramarathon medical team, as well as its members and descendants, directly or indirectly, are exempt from any and all liability. . A Medical Certificate is considered to be a document issued on letterhead, stamped and signed by a medical professional from the public or private network, of any specialty, registered with the Regional Council of Medicine (CRM) of your State/Country, also stating the name of the candidate , in addition to the legible identification of the issuer and the CRM registration number.*
 - b- *The Race Organization will only offer medical care at the points indicated in this Term, covering minor accidents, that is, those in which care and/or hospital admission is not necessary.*

The points indicated are: (will be presented at the Pre-Race Meeting)
 - c- *The Organization will provide a Medical Team for emergency care, with the aim of meeting the first needs and referring them to hospitals when necessary. This team will only take care of the "milder" cases, and it is the participant's responsibility to go to hospitals and/or medical centers, when requested. From this first appointment onwards, the participant must pay all other medical expenses.*
 - d- *Any athlete or member of the registered team who, during the Race, requires medical care in a hospital will be transported to the nearest hospital if possible. Once any injured person enters the*

hospital, the organization's medical team is exempt from any responsibility for what may occur. Due to Brazilian health policy, hospital costs must be paid by the injured person or another member of the registered team before the patient's discharge date.

e- The number of the athlete receiving care will be noted by the medical service, which will inform the Race management of the reason for the care. Once attended to, you should return in the same position and direction as when you left.

f- The Medical Team will have the authority to remove from the competition any athlete who is no longer able to participate or who has received vital medical care.

g- The Medical Team reserves the right to decide whether a member of the registered team will be able to continue participating in the Race after their care. If the Medical Team decides that such member should not continue to participate due to risk to their physical and mental integrity, the Medical Team must summon the organizer and declare their decision, technically justifying it.

h- The Race Medical Team will not be responsible, in any way, for any medical and/or rescue care provided to any athlete by personnel who are not or are part of the Official Medical Team of the BR 135 Event.

i- Any member of the registered team who is involved in an accident, who has suffered injuries, attacks or any other situation that threatens their physical and mental integrity, must, obligatorily, present themselves to the emergency team and report truthfully what happened to them. it happened.

j- Rescue, when necessary, will take place if there are favorable conditions that allow such an operation without risk to the athlete and the Rescue Medical Team. Therefore, I declare to be aware that, regardless of its severity or urgency, rescue will only occur when it is possible, if it is possible and if there is no risk or risk to the athlete and the rescue team for the eventual rescue.


9- I freely recognize and assume all risks, known or unknown, and assume full responsibility for my participation.

10- I, for myself, my heirs, legal representatives and close relatives, exempt and release the BR 135 Organization, the entire Medical Team, its collaborators under any relationship, agents or employees, from any legal responsibility, with respect to any and any damage, disability or death that I may suffer.

11- In the event of accidents, even if caused by the Organizers' faults or negligence, my family and I exempt the Organization and the entire Medical Team from any and all legal liability for any material or physical damage resulting therefrom.

12- I declare of my own free will to have understood and be aware of the entire content of the Race Regulations, the entire content of this Exemption Term, as well as my rights and obligations within the event, having been fully aware of the rules and regulations of the race and I accept all decisions of the Organization, committing myself not to appeal to any body or court, with regard to any punishment imposed on me by the Organization. I therefore exempt anyone from any and all legal responsibility for anything that may happen to me as a result of my participation in the event.

13- I understand that I am giving up substantial rights through my signature, which I do freely and voluntarily, without any coercion, in the presence of two instrumental witnesses.
